NOTIFICATION

WHEREAS the coverage of the Families of the Media Persons of Union territory of Puducherry under Medical Insurance Scheme for about ₹ 3 lakhs to each family in this Union territory, keeping in view the special nature of the service rendered by the Media Persons to the society in creating a sense of socio-political awareness among the people has been engaging the attention of the Government for quite sometime;

2. AND WHEREAS it has been proposed to lay down the procedure for the grant of such Medical Insurance by way of a Scheme.

3. Now, therefore, the Lieutenant-Governor, Puducherry, is pleased to notify a scheme for the grant of Medical Insurance to the Family of the Media Persons of this Union Territory of Puducherry as appended to this Notification.

**SCHEME FOR GRANT OF MEDICAL INSURANCE TO THE FAMILIES OF
THE MEDIA PERSONS OF THE UNION TERRITORY OF
PUDUCHERRY, 2015**

Short title, extent and commencement: -

- (i) This Scheme may be called the "**Scheme for Grant of Medical Insurance to the Families of the Media Persons of the Union territory of Puducherry, 2015**"
- (ii). It shall extend to the whole of the Union territory of Puducherry
- (iii). It shall come into force on and from the date of its publication in the Official Gazette.

2. Object: -

The object of the Scheme is to grant Medical Insurance to each of the Families of the Media Persons of Union territory, keeping in view the special nature of the service rendered by the Media Persons to the society in creating a sense of socio-political awareness among the people.

3. Definitions: - In this scheme, unless the context otherwise requires –

- (a). "**Committee**" means the Committee constituted under clause 7 of this Scheme;
- (b). "**Family**" in respect of the Media person shall for the purpose of the Scheme means his/her spouse and two children wholly dependent on him/her which term shall mean and include the following persons, namely :
 - (a) Spouse' means the first wife/husband who is legally wedded to the Media person;
 - (b) 'Children' mean and includes legitimate/illegitimate or adopted and unmarried and a minor or a daughter married and a minor and abandoned by the spouse or a daughter widowed and a minor.
- (c). "**Form**" means the form appended to this scheme;
- (d). "**Government**" means the Administrator of the Union territory of Puducherry appointed by the President under Article 239 of the Constitution;
- (e) "**Insurance Company**" means an Insurance Company authorized by the Government of Puducherry in this behalf to grant Medical Insurance to the Media persons and their families.
- (f). "**Media Person**" means an Media person of the Union territory of Puducherry who has got 'Accreditation Identity Card' under Pondicherry Press Representatives Accreditation Rule, 1984 or 'Press Identification Card' under Puducherry Media Representatives Identity Card Rules, 2013 from the Directorate of Information and Publicity, Puducherry.;
- (g). "**Medical Insurance**" means annual premium paid to the Insurance Company on behalf of Media persons of this Union territory under this Scheme.
- (h). "**Newspapers/Periodicals**" means any newspaper/periodical duly registered with the Registrar of Newspapers for India, Government of India, New Delhi.

4. Eligibility Conditions: - The following shall be the criteria for becoming eligible for Medical Insurance under this Scheme:

- (1). The beneficiary shall be a citizen of India and resident of the Union territory of Puducherry by birth or by continuous residence for a period of not less than 10 years;
- (2). The beneficiary must have put in not less than 10 (ten) years of service as full time Editor/Reporter/Sub-Editor/Press Photographer/Correspondent of a Newspaper/Periodical/News Agency including newspapers and periodicals published in the Union territory of Puducherry and News agencies having head quarters outside the Union territory.
- (3). The beneficiary must have Press Accreditation/Identity Card from the Directorate of Information and Publicity, Puducherry under "Puducherry Press Representatives Accreditation Rules" issued vide G.O.Ms.No.13/84-P & AR (IPT), dated 30.10.1984 or Press Identity Card under Puducherry Media Representative Identity Card Rules – 2013 issued by the Directorate of Information and Publicity vide G.O. Ms. No. 3, dt. 28.06.2013

5. Quantum of Premium:-

The Quantum of Premium per annum ranges from ₹ 4,500 to ₹ 13,500/- depending upon age of the applicants (See Annexure-I) or as may be fixed by the Government from time to time against the Family Health Insurance claim upto ₹ 3.00 lakhs in any one of the Registered Health Insurance Company in India. The premium payable by the Government will be worked out by the Directorate of Information and Publicity on the basis of the applications received from Media persons.

6. Making of application:-

The application for grant of Medical Insurance under this scheme shall be submitted to the Director of Information and Publicity, Puducherry in Form-I accompanied by the following certificates, namely:-

- (a). Nationality/Nativity/Residence certificate obtained from an Officer of the Revenue Department not below the rank of Deputy Tahsildar;
- (b). Birth Certificate or Transfer Certificate/School Leaving Certificate for proof of the age;
- (c). Service Certificate showing the designation, period of service and the place of work from the employer in Form-II.
- (d). Copy of the Accreditation/Identity Card issued by the Directorate of Information and Publicity, Puducherry.

7. Sanction of Medical Insurance: -

(1). All the applications received from the Media Persons under this Scheme shall be placed before the Selection Committee comprising of the following officials, along with a certificate of verification of the Assistant Director of Information and Publicity in Form-III.

- (i) . Secretary to Government (Information and Publicity) - Chairperson
- (ii) Under Secretary/Deputy Secretary to Government (Finance) - Member
- (iii) District Collector / Regional Administrator of the Region Concerned (for applicants from outlying regions only) - Member
- (iv). Director of Information and Publicity - Member-Secretary

(2). The Committee after satisfying itself of the genuineness of the application may approve the grant of Medical Insurance, after which the Director of Information and Publicity shall issue a sanction order in Form-IV appended to this Scheme.

(3). The Committee may reject any application for reasons to be recorded in writing.

(4). The Director shall maintain a Register of Sanction in Form-V.

8. Mode of Payment: -

Stipulated Premium shall be paid by the Directorate of Information and Publicity, Puducherry, every year and for every policy of the Medical Insurance to each family of the Media Persons as prescribed by the Insurance Company.

9. Record of Payment of Premium: -

Records of all the payments of premium shall be maintained by the Department of Information and Publicity in the Register in Form-VI.

10. Stoppage of Premium: -

(1) (a). The Director of Information and Publicity shall have the right to stop payment of premium if at any stage it is found that it was sanctioned on mistaken grounds or false information or the conditions on which the Medical Insurance was granted no longer exist.

(b). Before resorting to stoppage of the Premium to Medical Insurance under sub-clause (1)(a) above, the insured shall be given an opportunity of being heard in person or represented in writing.

(2). In case the Medical Insurance is sanctioned on the basis of wrong information given by the applicant, the amount already paid would be recovered.

(3). If, the family of the beneficiary leaves the Union territory of Puducherry for more than one year without any prior intimation or permanently, the payment of premium shall be stopped.

(4). The Director of Information and Publicity may however review the case, if he is satisfied that the beneficiary has returned to the Union Territory of Puducherry and continues to reside here.

11. Appeal: -

Any person aggrieved by any decision of the Director may appeal to the Secretary to Government in-charge of Information and Publicity whose decision shall be final.

12. Powers and duties of the Director of Information and Publicity: -

The Director shall be in-charge of implementing the Scheme.

13. Budget Provision: -

The expenditure towards the implementation of this Scheme shall be debitable to the budget of the Information and Publicity Department under the Head of Account of "2220-Information and Publicity-60/800 - other expenditure-60/800(02)- Welfare Programme for Media Persons-60/800 (02) (01) - Pondicherry Region-(50) - Other charges (Plan)"

14. Interpretation and Clarification: -

In the implementation of the Scheme, if any doubt arises with regard to interpretation of any of the provisions of the Scheme or if any point requires clarification, the matter shall be referred to the Secretary to Government (Information and Publicity) and the decision of the Government thereon shall be final.

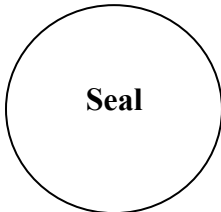
