**NOTIFICATION**

WHEREAS the scheme for providing Financial Assistance for the Purchase of Laptop or Desktop Computer to Media Persons of the Union Territory of Puducherry-2014 was notified vide G.O.Ms. No.01, dated 12.01.2015 vide reference 1<sup>st</sup> and the same is yet to be implemented;

2. AND WHEREAS it has been proposed to amend the scheme with necessary amendments in the earlier order notified vide G.O.Ms.No.01, dated 12.01.2015 in order to facilitate the Media Persons to choose Smart Phones, which are widely used by the Media Persons now-a-days;

3. NOW, THEREFORE, the Lieutenant Governor, Puducherry, is pleased to notify the amendment to the Scheme for providing Financial Assistance for the Purchase of Laptop or Desktop Computer to Media Persons of the Union territory of Puducherry as appended below to this Notification:-

**Short title.-** This scheme may be called "Scheme for providing Financial Assistance for the purchase of Laptop or Desktop Computer or Smart Phone to the Media persons of the Union territory of Puducherry [Amendment] 2015"

**Substitution of the words "Laptop or desktop Computer".-** In the Scheme for providing financial Assistance for the Purchase of Laptop or Desktop Computer to Media Persons of the Union Territory of Puducherry-2014 for the words "Laptop or Desktop Computer" wherever they occur, the words "Laptop or Desktop Computer or Smart Phone" shall be substituted.

**Addendum in clause 3.-** In clause 3 of the said scheme, a new sub-clause(h) shall be added, namely:-

(h) "**Smart Phone**" means a brand new Cell Phone, i-Phone, Tablet, iPad with all necessary accessories, excluding Simcard.

**Proviso to Clause5. –** In clause 5, the following proviso shall be included, namely:-

“Provided that in respect of “Smart Phone” the claim shall be restricted to one third of the cost of the device or Rs.15,000/- whichever is lower.
