NOTIFICATION

WHEREAS, the Scheme for Grant of Pension Benefits to the Media Persons in the Union Territory of Puducherry,2014 was notified vide G.O.Ms.No.1, dated 09.01.2003 vide reference 1st cited and subsequently amended vide G.O.Ms.No.3, dated 12.01.2015 vide reference 2nd cited;

AND WHEREAS, it has been proposed to amend the scheme with necessary amendment in the earlier order notified vide G.O.Ms.No.3, dated 12.01.2015 vide reference 2nd cited in order to enhance the pension benefits from Rs.6,000/- to Rs.7,500/- to the Media Persons in the Union Territory of Puducherry based on the assurance made by the Hon'ble Chief Minister on the Floor of the House during the Budget Session 2016-17;

NOW, THEREFORE, the Lieutenant Governor, Puducherry, is pleased to approve the said proposal and for the said purpose hereby makes further amendment to the then Scheme for the Grant of Pension Benefits to the Media Persons in the Union Territory of Puducherry,2014

AMENDMENT

1. **Short title.-** This Scheme may be called "Scheme for the grant of Pension Benefits to the Media Persons in the Union Territory of Puducherry [Amendment] 2017".

2. **Amendment in Clause 5.-** In Clause 5 of the scheme for the Grant of Pension Benefits to the Media Persons in the Union Territory of Puducherry for the word and figures “Rs.6,000/- (Rupees six thousand only)” the word and figures “Rs.7,500/- (Rupees seven thousand five hundred only)” shall be substituted.
3. **Effect of Amendment.-** This Amendment shall come in to force with effect from 01.04.2017
